

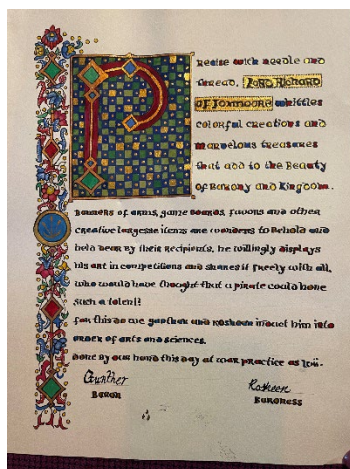
Court reports for July 16 2002 (AS 57) at the Bog 3 Day held at New Germany Grove, New Germany PA

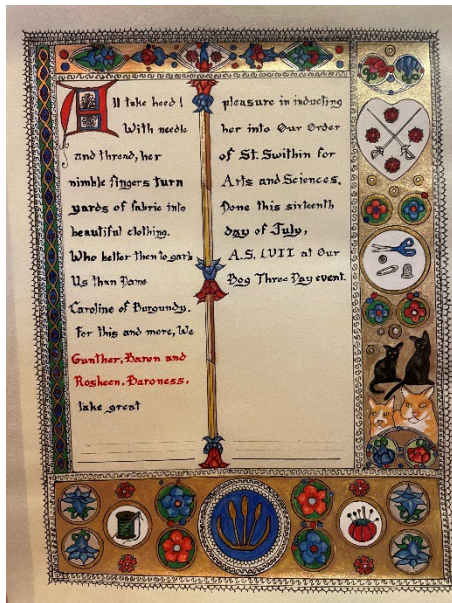
Sighvater Ravnsson and Unna were called but not available. One who could speak for them was called and their scroll given into their keeping until the recipients could be found.

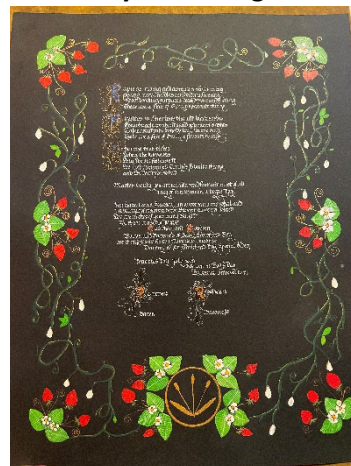
