Master Illadore, our Kingdom Seneschal, has asked our chroniclers to pass on a reminder that "doxxing" is against SCA policy and will not be tolerated. To dox is defined as publicly identifying or publishing private information about someone especially as a form of punishment or revenge. Chronicler is a required office for a Barony and applicants must hold a membership in the SCA (any level). Primarily the job entails editing and sending reminders for submissions and publishing the newsletter. Interested parties should have reliable access to the internet and computer software along the lines of Microsoft Publisher or Word—and the ability to save or convert the document to a PDF format.




Sighvater Ravnsson and Unna were called but not available. One who could speak for them was called and their scroll given into their keeping until the recipients could be found.
